1. The rates quoted shall be for free delivery & installation at CICR including everything except GST may be shown separately. However, equipment quoted in foreign currency must be quoted on FOB basis, Custom Duty Exemption certificate will be issued only when the bid is quoted in foreign currency in case of foreign made item only & meant for CICR, Panjari, Near Khapari Phata, Wardha Road, Nagpur (Maharashtra).
2. The firm participating in the tender will be required to deposit an account payee bank draft of ₹ **10,000/-** being the Earnest Money Deposit, in the name of “The Director, CICR, Nagpur” payable at Nagpur. Earnest Money in any other form shall not be accepted and the tender would be summarily rejected. The earnest money shall be refunded without interest after deposit of security money by the successful bidder. However, the successful bidder will be required to deposit security money calculated at **10% of the equipment cost** in the shape of Demand Draft in favour of “Director, CICR, Nagpur”, payable at Nagpur which shall be refunded after six months of successful completion of the contract. **No interest shall be paid on EMD.**
