You are, accordingly, requested to quote your rates in a sealed cover super-scribing envelop "**Tender for Providing High Speed Broadband Internet facility**" which should reach the undersigned up to **11/02/2019 by 01.00 PM** through Regd.post/courier etc. The quotations will be opened on the same day at **2.30 P.M.** in the presence of those bidders who may wish to remain present at the time of opening of tender. The award of contract will be governed by the following terms and conditions:-

**TERMS & CONDITIONS:-**

1. The payment shall be made quarterly upon submission of pre-receipted bill by the Co.
2. The firm has to provide acceptance immediately after award of the work
3. Income Tax will be deducted at source as per rules.
4. The contract will be awarded initially for a period of one year which is extendable but will liable to be terminated even before the expiry of the contract period if the firms fails to provide satisfactory services or violates any of the conditions/terms of the contract. In that event, the security money deposited by the firm will be liable to be forfeited.
5. The firm has to immediately attend complaints raised by office.
6. The contract also includes necessary repair by firm to its installed systems including replacement of defective/damaged parts, components and other accessories.
7. The selected agency will have to deposit 5% performance security of the total quoted amount which is refundable after satisfactory completion of the contract without any interest
8. Additional particulars to be furnished by the Bidder:
  - i. The Co. should submit valid proof of PAN/GST No.
  - ii. Name and full address of the bank
  - iii. Annual turnover and sales tax registration number of the firm.
  - iv. Service tax/GST no of the firm (if service tax charged)
  - v. If the tenderer is the dealer of any Co.(Authorization letter from the company) should be attached.
